II. Mandatory Criteria for the Professional Development Program Competition

Speech topics are available for the PDP on the website (<a href="www.bpw-ky.org">www.bpw-ky.org</a>) The state federation program sets the topic selection each year for local and statewide competition. It is recommended that topics for all levels of competition within the Kentucky Federation be coordinated. Topics are often based on the current state legislative platform, knowledge of the Equal Rights Amendment and the 3-state strategy, advocacy issues, and current events. The mandatory criteria apply to each level of the Kentucky Federation Professional Development Program Competition:

#### A. To be eligible, a person must:

- Be living, working, training or continuing their education in the area served by the sponsoring local organization conducting the program; and
- Be a member, in current standing, of a local organization; and
- Have completed the Professional Development Program within 1 year; and
- Have completed at least 7 (seven) of the 10 modules of the Professional Development Program; and
- If applicable, meet all State Award guidelines; and
- Be the LO Winner, Runner-up, or the officially designated representative of the Kentucky Federation; and
- Support the KFBPW mission and vision. Kentucky Federation Professional Development representatives must review the Kentucky Federation legislative platform and pledge that they will not speak against platform items in their capacity as a KF Professional Development representative, if selected.
- B. The KF Professional Development representative must have participated in the Kentucky Federation's selection program and must be a member of a Local Organization to be recognized as the Kentucky Federation Professional Development representative of that state conference.
- C. The selection process must include two (2) types of speeches delivered by the participant:
  - A 5-minute prepared speech and a 2-minute impromptu speech.
  - Each phase is timed with warnings given at 30 seconds before time; and, the timer standing at the 5 or 2-minute mark.
  - Timing begins when the participant starts speaking and ends when the participant stops speaking and steps away from the podium.
  - No props are allowed in the competition.
  - Judges are given a scoring sheet with instructions and are not allowed to interact with the participants until the competition is completed.

Audience Interest 1 - 4 max.

Timing 1 - 4 max. +/-10 seconds = 0 pts, +/-11 seconds = -10 pts
